Bemerkenswert ist die zeitliche Spanne der beschriebenen Bände von einer karolingischen Heiligenviten-Sammlung bis zur Abschrift des "Cymbalum mundi" aus dem Jahr 1809, mit einem Schwerpunkt im 15. Jahrhundert. Der weiten geographischen Streuung der einzelnen Codices vom schwedischen Vadstena bis Oberitalien, von Spanien bis Kurland (Polen) korrespondieren die nicht unerheblichen volkssprachigen Anteile in Altschwedisch, Mittelhochdeutsch, Mittelniederländisch, Französisch, Italienisch und Kastilisch. In der Mehrzahl handelt es sich um Liturgica und Paraliturgica; daneben sind eine Sammelhandschrift mit zahlreichen Gedichten des 12. Jahrhunderts und einige Bände mit kirchenrechtlichen Texten zu nennen. Die häufig für die private Frömmigkeit genutzten Stücke eröffnen in vielen Fällen den Blick auf bisher wenig bekannte Provenienzen, so dass den historischen Zusammenhängen besondere Aufmerksamkeit zuteil werden musste.
